

ACCEPTANCE OF RISK AND WAIVER OF LIABILITY

Copenhagen Air Experience A/S (hereafter written CAE), company reg. no. 29820708, has a wind tunnel that simulates the free fall at parachute jumps. Five engines create a vertical wind current of over 200 km/h, which allows persons to fly up to 10 meters in height. As your safety is our first priority our wind tunnel is TÜV approved and all our instructors have completed a specially certified instructor education. Still, bodyflying must be considered to be a dangerous sport, involving a risk of incurring both personal injury and damage to property.

In accordance with the forthcoming bodyflight experience, the undersigned participant hereby issues the following statement to CAE and its affiliated personnel:

- My body weight does not exceed 120 kg. and I am not pregnant
- I am completely well and in good health and do not suffer from any actual or former injuries, dislocations or disorders of the neck, shoulders, back or heart conditions. I understand the importance of good health due to the significant pressure during the flying, especially on the above-mentioned body parts
- I am not under any influence of alcohol or psychedelic drugs. Nor am I taking any kind of medicine, which could affect my ability to react or influence my balance or perception
- Before flying, I will look and listen carefully when viewing the CAE instructional video and seeking answers to all my relevant questions in this regard. I hereby familiarize myself with the CAE's instruction and safety rules and agree to follow these, as well as the instructor's other directions both before, during and after flight
- CAE will provide safety equipment in the form of a helmet, suit, gloves and ear plugs at my disposal. I understand that it is important to keep the helmet fastened, the face shield closed and keep the ear plugs in my ears to minimize the risk of damage. The noise in the tunnel can be up to 120 dB, which can easily cause hearing damage if you do not use earplugs. I commit to properly carry the lent security equipment all the time during the flight and stay in the tunnel
- I ensure to empty my pockets before flying and do not carry any jewelry, watch, glasses or other loose items during the flight. CAE is not liable for any damage, theft or loss of personal effects
- I make sure to have a proper warm-up before flying and I will only be entering the flight chamber if accompanied by a CAE instructor. Furthermore, I will only commence my flying upon approval from my instructor. Unless I have explicit permission from the instructor for anything else, I only make a flight in a horizontal position and try not to perform tricks, flips or the like
- I am personally responsible for any insurance deemed necessary to cover my risk and I have become aware of the extent to which my accident insurance covers any bodily injury or property damage in connection with my participation in activities at CAE
- I am fully aware that bodyflying as well as my stay on CAE's premises is at my own risk and consequently, I take full responsibility for my participation in all activities. Also, I am fully responsible for any property damage or personal injury, which I may incur in this regard.

 Furthermore, I waive the right to claim any damages from CAE and CAE's employees including instructors, operators, receptionists and others. I also promise to indemnify CAE for any liability to pay damages arising out of my participation in bodyflying
- I hereby give my consent to CAE to record video and photos in connection to my activities at CAE and accept that this material belongs to CAE. The video will be deleted again from CAE's systems after 7 days
- I accept that this waiver of liability is kept for 5 years, in accordance to the accounting legislation and documentation of instruction and disclosure requirements for safety and risks
